- Texas Commission on Environmental Quality (TCEQ) "C" Water and Wastewater licenses required (or ability to obtain within 6 months of hire).
- Valid Class C Texas driver's license.
- Reliable transportation and liability insurance.

## 3. Other Requirements:

- Experience working in communities experiencing rapid growth.
- Proficiency with Microsoft Office (Word, Excel, PowerPoint, Outlook).
- Knowledge of municipal budgeting and asset tracking.
- Exceptional customer service and communication skills.
- Appointment will be conditional upon successful completion of the following preemployment checks:
