# **Ethical Behavior Collectively**

When you study ethics it is often done in a way such that the individual is your unit of study. In other words, you study ethics so individuals know how to act with high ethical standards. This is important. Ultimately, most decisions are made by individuals.

It is also important to consider ethics in a more collective way. This is the idea of organizational ethics. Organizational ethics are "the policies, procedures, and culture of doing the right things in the face of difficult and often controversial issues" (Leonard 2019). Stated another way, ethics in the context of municipal government is the philosophical and morally decent standards that a municipality attempts to stand by even in difficult circumstances. Ethical dilemmas that might challenge a municipality include topics such as discrimination, improper use of funds, improper use of city-owned resources, waste of resources, misuse of official position, social injustice, or conflicts of interest.

As stated above, ultimately the decisions made by individuals will have the most impact on these types of situations. The organization, however, must be a place that demonstrates, models, and expects high standards of ethical behavior. A municipal official should understand the ethical nature of his or her position in the municipality in such a way to recognize how he or she can positively impact the greater good of their town or city. According to M.J. Mafunisa (2001) local governments, as a collective unit, must:

- adhere to a high standard of professional ethics (such as the TMCA Code of Ethics)
- promote the efficient, effective, and economic use of resources
- provide services impartially, fairly, equitably, and without bias
- be accountable

Moreover, municipal leaders should build and sustain an ethical culture by offering training, communicating the importance of an ethical culture, and investigating ethical risks that may be present in the organization. They should ensure that the code of conduct and/or code of ethics is implemented. When the organization has stressed the importance of ethics to the collective group, then individuals within the group know that ethical action is expected of them in every situation and at all times. Organizational ethics are interdependent with the organizational culture. Organizational ethics affects almost every aspect of a municipality's ability to provide services to citizens.

# Texas Municipal League Report

The TML Board of Directors met on March 29 in Austin. The board ratified the selection of Dallas as the 2023 location for the TML Annual Conference. The conference locations for the next several years are: San Antonio—2019, Grapevine—2020, Houston—2021, San Antonio—2022, and Dallas—2023.

The board also received a membership report listing 1,159-member cities, with the newest being Double Horn, population 238. There are 64 cities who are not League members, and of that 64, 62 are 2,000 or fewer in population, and two are under 5,000 population.

TML staff updated the board on the legislative session with a strong focus on revenue caps. The Board ratified the following actions of the TML Executive Committee with a unanimous vote.

#### Relating to Workers' Compensation and Cancer Presumption for Firefighters

The Executive Committee decided that no change is needed to the existing position in the legislative program (oppose legislation that would substantively change or expand the scope of the current disease presumption law, unless doing so is supported by reputable, independent scientific research) and that staff should move forward with negotiations. [with Texas firefighter groups]

#### **Relating to Opposition to Revenue Caps**

The Executive Committee reaffirmed the League's position on revenue caps (to oppose legislation that would impose a revenue and/or tax cap of any type, including a reduced rollback rate, mandatory tax rate ratification elections, lowered rollback petition requirements, limitations on overall city expenditures, exclusion of the new property adjustment in effective rate and rollback rate calculations, or legislation that lowers the rollback rate and gives a city council the option to re-raise the rollback rate) and directed League staff to stay the course in opposition.

The Executive Committee asked that the TML president strongly communicate to the membership the situation, the League's position, and the Executive Committee's support for League staff.


