TMCA is established under LGC 22.074.

Plants are a part of nature that thrive wherever there is sunshine and water. Some are strong; some are gentle. Behind every plant, whether big or small, lies a symbol, a hidden meaning that can be discovered by those who embrace it.

Succulents symbolize enduring and timeless devotion, for they are tenacious plants adorned with dense and strong leaves and stems that allow them to store water.

They offer us a positive example by conserving water and flourishing in very difficult circumstances, reminding us that we are stronger than we realize, even in the most arduous situations.

Succulents provide essential elements to our environ*ment*-*just as the officers provide essential obligations* to the chapter.

"This plant can purify the air by emitting a water vapor that turns contaminants into nourishment for the plant.

"Gabby, as Treasurer, you will be responsible for maintaining pure and accurate financial records for the chapter, keeping them free of 'contaminants' or errors, and ensuring there are funds to 'nourish' or sustain the chapter."

#### SECRETARY April Hilbrich City Secretary, Victoria



"This plant can enhance your memory. Research conducted by the University of Michigan showed that memory retention was improved by as much as 20% after subjects spent an hour with nature, including even just looking at photographs of flowers and plants.

"April, as Secretary, you will be responsible for keeping the 'memory' of the chapter by retaining accurate records and a history of the chapter."

"Rebecca, as President, you will be responsible for setting and keeping the focus of the chapter and implementing the goals of the membership. This will require you to be focused and attentive to members and the business of the chapter."

"And now to the chapter members. Succulent plants can brighten a home in any climate – from seaside cliffs, humid jungles, bone-dry deserts, or frosty mountains, they naturally thrive as long as there is sun and water. Without sun, they grow pale; and with too much water, they wither.

"There are over 10,000 known succulent varieties around the world, and they come in all different shapes, sizes, and colors. Just as you as chapter members come from different cities and towns; some of you are freshly planted seedlings and some are seasoned; some are strong, some are gentle; all varieties brighten whatever "climate" or environment you are in by flourishing under any circumstance, enduring all situations, and thriving with the perfect amount of both sunshine and water.

"Succulents bloom best when they are expertly grouped together to support each other throughout the seasons. Just as these officers have been selected to lead, you are asked to support them and the chapter by serving as active members.

## **TMCA Executive Board Update**

The TMCA, Inc., Executive Board met in Dallas on March 26, 2021. All board members attended including the newest trustees, Jeana Bellinger, TRMC, City Secretary, Brenham, and Michelle Hicks, TRMC, City Secretary, Lacy Lakeview.

The Board appointed Amanda Campos to serve as President-elect for the remainder of the 2021 term. Maria Jackson, City Secretary, Missouri City, former President-elect, submitted her Board resignation in February due to personal commitments.

The Board reviewed the Association's financials and approved a clean Audit Committee report.

The Board received the directors' reports. TMCCP statistics reporting 1,026 graduates to date, 59,2021 graduates, 62,2021 recertification graduates, over 600 active enrollees, and over 950 members (at the time of the March report)

Administrative Director Sheehan advised the board of two new scholarships.

The Board received an update from Education Director Holt on 2021 seminars including webinar options. The Board received the Award of Excellence Committee report and approved 25 Municipal Clerks Office Achievement of Excellence awards to be bestowed to:

The Board approved a \$400 scholarship that can be awarded for a webinar 6-pack.

The Board approved the following recertification credits for webinars effective January 1, 2021, with certain requirements: 5 points for 2 webinars 10 points for 4 webinars 20 points for 6 webinars

The Board changed the nomination deadline for Municipal Clerk of the Year to July 1 effective with 2022 nominations. (The 2021 deadline has been extended to July 9.)

The Board discussed the 2021 TML Annual Conference and how TMCA will participate.

It goes without saying that the pandemic has affected the way we serve the members of TMCA. Just like in your cities and towns, we have had to change on a dime and figure out new ways to provide education. One way we have done this is with webinars. We offered our first webinar August 31, 2020. We offered fourteen webinars last year. This was an effective way to facilitate learning,

many in this short amount of time to ensure that those individuals who were due to graduate in 2020 had the opportunity to complete their graduation requirements. We continue to offer webinars not only because of the continuing pandemic, but also because we recognize it is an effective education option for those of you who find it difficult to be out of the office and travel to seminars for many different reasons.

This year we will offer six webinars. The Certification Committee and the Executive Board voted to allow these webinars to be used for your certification efforts. Currently, if you are pursuing your initial certification you can complete six webinars to take the place of one seminar attendance requirement. You can only do this once during your initial certification. Learn more here.

If you are pursuing recertification you can complete six webinars to take the place of one seminar attendance requirement. You can only do this once for each time you recertify. You can also use webinars to complete your education points for recertification. (Please note the same webinars you use for seminar attendance credit cannot also be used for earning education points.) **More information here.** 

We know there are many benefits of both virtual and in-person seminars.

Virtual seminars take away the barrier of travel. If you live in a geographically remote area, then virtual learning is really advantageous for you. Additionally, when you are an office of one, we know that it can be impossible for you to travel to seminars with much frequency. We are also mindful that your personal lives may make it very hard to be away for multiple days. Finally, we understand that even though our seminars are one of the best values out there, it is still expensive to travel to our educational offerings due to tight budgets.

In-person trainings allow the attendees to remove themselves from their regular environments and concentrate on learning. Also, we recognize the importance of your ability to network and interact with other city secretaries at in person learning events. This interaction allows you to exchange ideas and provide support to one another. Finally, the nature of being able to listen to a lecture or workshop and participate in person increases learning exponentially.


The Capital Chapter last met for our regular virtual meeting on March 17.


The North Texas Municipal Clerks Association (NTMCA) has continued to meet virtually, but are excited to meet in person for our Awards Banquet in June.
