Dr. Amy Holt Awarded IIMC's Institute Director Award of Excellence

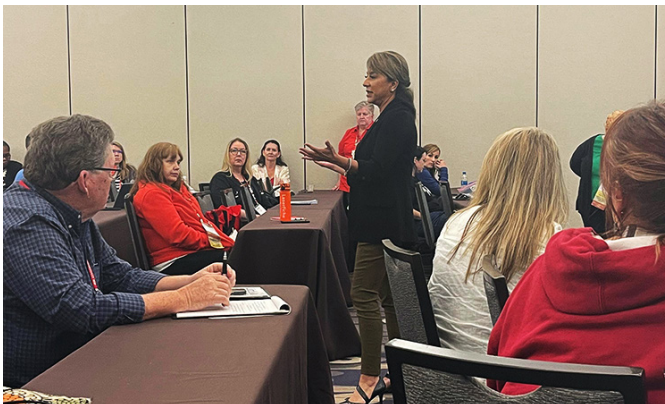

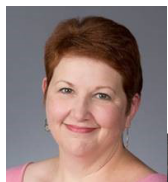

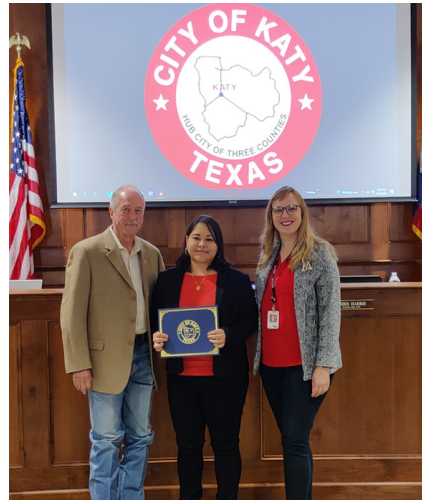
