



TMCA EXECUTIVE BOARD UPDATE

The TMCA, Inc., Board met in Dallas on July 23. All board members attended except Trustee Alicia Richardson, North Richland Hills, and Trustee Cara McPartland, Salado.

The Board received the Directors' Reports and TMCCP statistics reporting 1,026 graduates to date, and a record 1,066 members!

The Board reviewed the June seminar/webinar attendee surveys.

The Board reviewed the Retirement Committee Report and the list of retirees to be recognized at the Annual Awards Banquet.

The Board reviewed the Municipal Clerk of the Year Committee Report and recommendations for process improvements. The Board directed the Committee to review eligibility requirements and submit a recommendation to the Board for the October Board Meeting.

The Board reviewed the Awards Committee Report and recommendations for process improvements.

The Board reviewed proposed resolutions to be considered at the Annual Business Meeting in October.

The Board reviewed the Scholarship Committee report and recipients.

The Board approved the Nominating Committee report and the 2022 slate of officers and trustees for consideration at the Annual Business Meeting. The Board also approved a recommendation from the Nominating Committee to require ethics, diversity, and inclusion training for all board members. The Board determined to appoint an Ethics Review Committee to review the TMCA Ethics Policy.

The Board approved the following changes to the Certification and Recertification Requirements in Chapter 14 of the TMCA Policy Manual:

Certification Requirements

Of the eight required seminars, two may be attended virtually (effective January 2022) Five of the required seminars must be attended inperson. Three may be attended via distance learning through one series of six webinars and two virtual seminars.

Recertification Requirements

Of the six required seminars, two may be attended virtually (effective January 2022)

Three of the required seminars must be attended inperson. Three may be attended via distance learning through one series of six webinars and two virtual seminars.

The Board approved an amendment to the bylaws to require written notice of proposed bylaw changes to the membership at least 30 days prior to the meeting at which the amendment will be considered. The proposed bylaw amendment will be considered at the Annual Business Meeting in October.

The Board received various TMCA Committee and Chapter reports.

MENTORING AS A MUTUALLY BENEFICIAL PARTNERSHIP

Do you want to help your peers take steps forward in their career? Mentoring is a great way to do that. Both as a "mentor" and as a "mentee," you can be an effective force to help someone progress in their chosen career path. Whether that be a promotion, taking on a new assignment, or becoming a supervisor, a mentoring relationship can help both parties develop skills and attributes that allow for forward progress towards their professional goals. Mentoring can be defined as a more experienced team member guiding and developing the knowledge, skills, and abilities of a peer. The "mentor" is usually viewed as the more experienced team member, but this is not always the case. Sometimes the "mentor" is less seasoned in the profession, but is very advanced in a particular skill set or personal attribute that the more seasoned "mentee" needs to acquire to strengthen their professional development goals.

If you want to be in a mentoring relationship consider these eight points (from Dr. Todd Dewett of "Authentically Accelerated") for a successful mentoring experience.

MENTORING

Agree on a process with the other person

- When will you connect
- How frequently will you connect
- What are the topics you will address
- What communication channels will you use

Articulate the specific goals and skills to be attained

- What are the two to three specific goals to attain
- What milestones and skills will be needed to reach those goals
- What resources are needed to reach these goals

Be proactive to break down any status-related friction due to differences in knowledge or position

As the mentor, do anything you can to break down any "weird" feelings the less seasoned person may have due to perceived or real status differences

- Write the mentee a quick note to let them know you are thinking of them
- Go out of your way to say "hello" either in person or virtually whenever you can
- Tell them you are excited about the progress they are making

Probe with questions

- Don't just give out advice
- Listen with probing questions so you can evaluate what they already know and what their limits are
- Example questions:
 - What do you think about that?
 - What do you think the options are?
 - What would be some implications if you went a certain way with your decisions?

Making connections

 Expand the mentee's world by connecting them with people that might enhance their development

"First is the opportunity to step outside of your comfort zone, like I did when I accepted the opportunity to stand in front of a group and speak at a conference—I am terrified of public speaking—but I decided to embrace the opportunity to step outside of my comfort zone.

"I love the opportunities to learn—not only at conferences, but from others through the email group. When someone reaches out with a question or new situation, there is always someone there who has gone through something similar and can lend a helping hand.

"I love the opportunities to grow professionally and personally through education and networking.

MENTORING

- Until they have proven themselves (that they are worth the risk of giving them your stamp of approval as a professional) connect them with groups where they can continue to learn
- Once they have proven that they are a "rock star" you can introduce them to a specific individual in your network who they may benefit from chatting with

Providing feedback

- Being a mentor is partially about being a cheerleader, but it's also about giving critical, difficult feedback
- Consider how the mentee best "hears" feed-back. Is it in written form? In person?
- Provide examples of what they are doing well and where they can improve.
- When you are suggesting improvements make sure to include some concrete steps they can make as they concentrate on forward progress towards their goals.

Be authentic

- When you are the mentor, the mentee knows how great you are. Otherwise they wouldn't want you as a mentor. You want to continue to be the well-respected professional they see you as.
- Show them the real, whole person that you are:
 - Tell them a little about your family
 - Tell the about a great learning moment you had
 - *Tell them about your failures*

 If you do this, it is another way to break down the status differences in your relationship so they can relax and listen more deeply to you

Checking up

- Are we doing more than having great conversations in this mentoring relationship?
 To do this, ask questions such as:
 - Is the mentee doing something with my advice
 - Do you see evidence that they are moving forward
 - *Are you still the right mentor for this person*

The Texas Municipal Clerks Association is an organization where mentoring "just happens." We have a great group of individuals who are willing and able to mentor. 2021 TMCA CERTIFICATION COMMITTEE

The TMCA Certification Committee promotes the Texas Municipal Clerks Certification Program and sets the policies and procedures for the operation of the Certification Program.

This is a brief introduction of the TMCA members who have comprised this vital committee in 2021.

Certification Committee Chair Irma Parker,

TRMC, has served as Addison city secretary since 2018. She previously served as city secretary for the City of Port Aransas from 2013 to 2018, and as city secretary for the City of Rockport from 1998 to 2013.

Irma earned her TRMC Certification in 2008 (No. 536), has recertified twice, and is currently enrolled in her third recertification.

Irma is active in TMCA, where she has served on the Advisory Management, Membership, Resolutions, Scholarship, and Nominating Committees; this is her seventh year serving on the Certification Committee, the last two years serving as chairman. She is a speaker for the TMCCP Election Law

Seminar, and has also convened at TMCCP Election Law Seminars. Irma has served as president, vice president, treasurer, and secretary of the TMCA Coastal Bend Chapter.
