- Set a new record for membership with 1,035 members.
- In January, TMCCP graduated 43 first time graduates and recertified 49 TRMCs. There are currently 967 graduates and we will top 1,000 graduates in the 2021 class.
- Enrolled 83 new participants in TMCCP.
- Currently, there are 470 enrollees pursuing certification and 385 pursuing recertification.
- Awarded \$11,910 in seminar registration scholarships and travel stipends to 40 members.
- Awarded \$12,000 in major scholarships thanks to the generous support of our sponsors.
- Established the Legacy Scholarship and awarded a \$500 scholarship to Brenda Craig, retired from Kerrville; and Sherry Mashburn, retired from College Station.

and many other options. This project will only grow and expand over the coming years.

- Established an Ad Hoc Committee to bring forward ideas to promote our profession by providing resources to our members. Mary Kayser is chairing this committee with Mary Lynne Stratta, LeAnn Gallman, and Sherry Mashburn.
- Adapted four of our 5 TMCCP Seminars to comply with Covid-19 health protocols to ensure the safety of 1,116 attendees.
- Moved the Graduate Institute to a 100% virtual learning environment with 250 attendees attending a new three-day format through their computers from their home or office.
- Starting 2021, the Graduate Institute will be known as the Advanced Institute. This new title better identifies the type of learning opportunities provided at this seminar along with aligning our program with the International Institute of Municipal Clerks.
- Created an online educational learning platform to expand opportunities for our members to continue learning especially with so many facing travel restrictions. This year, we provided 14 different webinars with 533 attending live and 275 attending through video on demand.

 Adapted the Annual Meeting and Annual Awards Banquet to virtual gatherings which provided for more of our members, sponsors, colleagues and friends to join in on the celebration of our peers for their accomplishments and to witness the transfer of leadership for 2021.

The Municipal Clerk of the Year Committee scores nominee applications on years of municipal service, years of TMCA membership, TMCCP certification/ recertification achievements, TMCA service, local chapter service, special projects service, IIMC service, and participation as instructors or conveners in TMCA, local chapter, and IIMC education sessions.

Those words have stuck in my head all these years and I have repeated them to others who were in my shoes. I've also had other mentors along the way. Chief Shan English, former Wylie Fire Chief, who did not take me with him; Pam Schmidt, who was my predecessor in Richardson; Patrice Fogarty, retired city secretary, whom most of you know; Mary Kayser, Fort Worth city secretary, whom most of you also know; and a mentor to many in this room, Mary Lynne Stratta, City Secretary and Communications-Legislative Director for the City of Bryan. As they have mentored me, I hope that I can be a mentor to some of you, and hopefully, I already have been.

Now, let's do something we all want to do! Let's look forward to 2021! Don't you know the countdown to 2021 on New Year's Eve is no doubt one of the most anticipated moments of the year? Wherever you are, make plans to be awake for that midnight toast! Even if it has to be on Zoom!

Besides just a new year and getting us out of 2020, 2021 brings us something exciting to look forward to. TMCA will celebrate our 35th year of incorporation. I'm very excited to lead you in this important year as we commemorate this milestone in our Association's history. As with anything worth celebrating, we should look ahead and be hopeful, but we cannot do that without

knowing where we've been. So, with that, let me introduce a theme for the year, with a little play on words and a slight twist of historical meaning: "Hindsight is 2020!"

First, you will notice, I mean 20/20 - as in perfect vision; but I also mean the year 2020 and the lessons learned. Second, you might know the definition of the phrase to be a look back to see where we went wrong, but I challenge us to look back and see where we went right. And I'm not just talking about our Association, our cities, our profession: I'm talking about you personally. How many times did you hear the word "essential" this year? Essential services, essential supplies, essential workers. Did you count yourself as essential? I hope that you did. Maybe you were one of the only employees to run your city. Maybe you were the one left to figure out how your council was going to conduct business, or maybe you were essential at home as your child experienced virtual learning. And likely, many of you did all of the above and more. When you look back at 2020, what did you do right? Did you learn a new skill? I think we

all learned Zoom... and I think we're all over it. (Except for today's presentation of course!) My sister-in-love perfected pie making-and I mean the kind with gorgeous intricately decorated crusts. My mom learned to make masks with material perfectly matched to any personality. I listened to new books and new podcasts on my commute-which quickly became much shorter with no traffic! I also binged watched old and new shows... from I Love Lucy episodes to Parenthood to Ozark. I learned not only how to say the word, but how to make a charcuterie board. I also learned that nothing we fill our lives with can replace the relationships-the in-person relationships-we have with our family, friends, and co-workers. We need the human touch, the human experience; these are essential and can't be achieved on a screen. We are essential. I am essential. You are essential. You are essential at home, in your community, at work, and to this Association. You are essential to this profession.

City Secretary, City Clerk, Municipal Clerk. These are our titles. But also emerging are many functional titles: Chief Compliance Officer, Chief Governance Officer, and others that are being developed across the state. I applaud these efforts and encourage our Association to lead these discussions. Our profession is also often referred to as the "heart of our cities," the "stars of local government," the "hub of our towns" to name a few. And these are all true! See, I told you we are essential. And as said by many others before me, but specifically, former TMCA President, Mary Lynne Stratta, it is up to us to tell our story if we want it told right. Chinese philosopher Confucius said, "Study the past if you would define the future." So as we look back, whether it's 2020, or back to 1986 when TMCA was incorporated, let us learn from our challenges, focus on the positives, and define our own future-both personally and professionally.

When I started drafting this speech, I went through the traditional outline process and started developing my main points. But as I started writing, I started thinking: nuggets. I just want to give you little nuggets. In this

world of soundbites, it just seems more contemporary. Or maybe that's just my excuse for not developing a main point. Either way, I hope you found a little nugget that you will remember.

If you didn't, let me leave you with this.

As a nod to my Greek heritage, and borrowing a favorite from my City Manager, Dan Johnson, I want to share with you the words of the Athenian Oath.

"We will never bring disgrace on this our city by an act of dishonesty or cowardice.

We will fight for the ideals and sacred things of the city both alone and with many.

We will revere and obey the city's laws and will do our best to incite a like reverence and respect in those above us who are prone to annul them or set them at naught.

We will strive unceasingly to quicken the public's sense of civic duty.

Thus, in all these ways, we will transmit this city not only, not less, but greater and more beautiful than it was transmitted to us."

As city officials, our profession is the embodiment of this oath. We strive for and achieve these tenets every day.

Part of the TMCA Code of Ethics states that members will

Record keeping and preservation are important parts of the municipal clerk profession. Even if your municipality has a separate office or individual devoted to records

management, the importance of accurate public records cannot be overstated. Our democracy only works when the public is informed about how decisions are made that govern them. Public records are the foundation of public trust.

As a custodian of public records, municipal clerks must act with integrity as he or she promotes best practices for creation, distribution, preservation, protection, retention, and disposal of public records. The National Association of Government Archives and Records Administrators points out that "trust in records can only be ensured if the processes for management and decision-making are concisely and plainly articulated."

Each year the Texas Municipal Clerks Association provides training related to records management. We also offer a fantastic **webinar** that can be purchased at any time for training purposes.
