TMCA EXECUTIVE BOARD UPDATE

The TMCA board met in Galveston on October 27. All board members were present. 2022 incoming officers-elect were invited to attend as guests. President Nemer introduced the following new 2022 TMCA trustees: Deborah Sorensen, City of Royse City; Ellie Monteaux, City of Livingston; Roxanne Benitez, City of Spring Valley Village; Sharon McFadden, City of Graham; Irma Parker, City of Addison; Laure Morgan, City of Brownsville; Rebecca Huerta, City of Corpus Christi. 2022 TMCA Trustee Crystal Roan, City of Pearland, was unable to attend.

The Board received the directors' reports and TMCCP statistics reporting 1,026 graduates to date, 59 2021 graduates, 62 2021 recertification graduates, over 600 active enrollees, and 1,100 members

The Board reviewed the Association financials, August seminar and webinar surveys, and approved the Board Minutes

The Board heard reports from the following committees:

Membership Committee, noting the committee's efforts to achieve 1,100 members for 2021

Technology Committee, noting the committee's contributions to increased membership due to the Google Group requirement of active membership

TML Booth and Session Committee, providing an update on the TML Annual Conference/TMCA Session and booth activity

Certification Committee on upcoming revisions to the Municipal Clerks Handbook, recommended changes to the Certification/Recertification requirements, and a report of scholarships and substitution requests

The board received a report from TML Board Liaison Amanda Campos regarding TML's continued focus on local participation by elected/appointed municipal officials, and the success of the 2021 Annual Conference

The board reviewed the 2022 Board Meeting Schedule and Board Retreat and Training dates.

The TMCA board met in Dallas on November 12. All board members attended except Trustee Gretchen Mercer, Canyon; Trustee Cara McPartland, Salado; and Trustee Teresa Valdez, Rockport.

The Board reviewed the October seminar/ webinar attendee surveys

The Board reviewed the Municipal Clerk of the Year Committee Report and approved the revising the point allocation in the following categories:

- Decreasing points for Board Service
- Increasing points for TMCA Committee and Committee Chair service
- Increasing points for Chapter service
- Decreasing points related to IIMC service

Additionally, the board directed the Municipal Clerk of the Year Committee in conjunction with the Past Presidents Commission to review the award in its entirety, with a reporting timeline

EXECUTIVE BOARD UPDATE

The Board approved changes to the Board Attendance Policy to define attendance and clarify circumstances for virtual attendance at Board meetings.

The Board approved the 2022 TMCA and TMCCP budgets

The Board approved the 2022 Committee Appointments

The Board considered nominations for the 2022 IIMC Quill Award

The Board approved a membership incentive offer to allow all members who have paid 2022 dues by the end of 2021 be entered into a drawing for a one-time seminar registration

The Board approved bylaw and policy changes to allow associate members to serve as members of TMCA committees

The Board approved establishing a Bylaws Committee

The Board approved the following changes to the Certification Committee Policies and Procedures:

TMCCP Travel Stipend and Seminar Registration Eligibility Requirements

- Applicant must be currently employed by a municipality in Texas.
- 2. Applicant must be a paid member of the Texas Municipal Clerks Association, Inc.
 - a. Applicant must be actively pursuing certification or recertification in the Texas Municipal Clerks Certification Program, and the seminar/webinar(s) for which application is made must be necessary to complete certification or recertification requirements.
 - b. Applicant pursuing first time certification must have completed one course of homework and successfully passed one exam.

WHAT'S IN A NAME

"What's in a name? That which we call a rose, by any other name would smell as sweet." Shakespeare is saying that it doesn't matter what you call something, it is what it is; or to put it another way, just because you give something a different name doesn't change what it is... *Or does it*?

I've worked for federal, state, and local government, and local government is my favorite. Being a Child Protective Investigator was tough, but the work was rewarding. Most folks knew what the work entailed because the title is pretty descriptive of the work. Working for FEMA's Office of National Security as a Program Analyst was boring. The title was supposed to throw a curveball to everyone, or else it wouldn't have been the Office of National Security. Then came local government, and this is where I found my home. First as a Neighborhood Revitalization Specialist, then as a Public Information Officer (PIO) (commonly known now as a Communications Director), and finally as a City Secretary (CS). All these titles are self-explanatory, except for that of the City Secretary. I'd never given titles much thought before I became a CS. After obtaining my master's degree in public administration I wanted to go into city management. A close friend of mine, who was a city manager, told me to go the route of a CS because it worked closely with the city manager's office.

I was all of 25 years old and that sounded good to me, so I did!

Fast forward 20 years, and I am still a CS, only one with an additional title, that of City Secretary/Chief Compliance Officer for the City of Irving. I won't lie, I never truly understood the title CS, which likely in part contributed to my dislike of the title. Having worked for several different sizes of cities as a CS-Prosper, Bedford and now Irving-I began to grow frustrated with the title. However noble and historical the title is—and it IS both of those things—I do fundamentally believe the implication of the word "secretary" or "secretarial work" in and of itself is debatable as to whether or not it's slightly demeaning in today's society. To me—and that's why this is an opinion article—I would argue 60/40 that it is demeaning. Stewardesses are now flight attendants, legal secretaries are now administrative assistants, and office staff for CEO's are now executive assistants. One could argue, and I am making the argu-

ment, that advancement must occur within our association to begin to move beyond the word "secretary."

Secretary is defined in Merriam-Webster Dictionary as one employed to handle correspondence and manage routine and detailed work for a superior. It is also defined as an officer of state who superintends a government administrative department (i.e., Secretary of Labor).

Being a CS is an awesome responsibility with a lot of accountability. But after a few years, you may begin to take notice of the nuances that exist within this strange world that is called the "City Secretary's Office." Sooner or later, most CS's, if they are being honest with themselves, have made a few observations. First is the observation that your colleagues are predominately female; where are all the males? Don't look at me, I hired one that is now a CS in his own right! Second, no matter how hard you work—it can be as hard if not harder than the next department head—you are still likely one of the lowest-paid department heads on staff, yet you do the crème de la crème of hard work for the governing body

with all your responsibilities. And finally, after making both of those observations, you may realize some CM's, if not most of the council, don't know what you are trained to do. There is this lack of understanding about what your job responsibilities are, coupled with the word "secretary," which inevitably equates into the lack of parity in compensation.

And then you ask yourself, what is the problem with this picture? For me, the only noticeable or clearly identifiable thing I can come up with in all these years is the word "secretary." The one single word that is so traditionally woven into the fabric of our profession, I believe is the one word that is holding our profession back. The fact of the matter is that we are not the Secretary of State, and we are not the Secretary of Defense. We are "City Secretaries" and that is not, by the masses, a well-known title. Therefore, I sought a title change.

The process began by me redoing my job description with the assistance of the City Attorney's Office and Human Resources. At the same time, I had been benchmarking, me specifically-not HR, various cities within my metropolitan area and outside of it as well—to see if anyone else had a different title. One that wouldn't marginalize what a CS is or does, but would describe it in such a way that the position didn't have to be defended as mission-critical to the city operations. I garnered information on what other CS offices' job duties were, their responsibilities, job titles, whether their offices were decentralized or centralized in open records requests, and the same with their records programs. I asked about their reporting structure, who conducted the CS performance evaluation, the city's population, salaries, tenure, education level, number of staff (both CS and records), and any additional duties not widely known to be a CSO duty.

After I attained all that information my staff assisted me in organizing it in such a way that I had talking points and graphs/tables that clearly defended my request for both my merit increase and for my additional title. The additional title was going to be the difficult one to sell and I knew it, because I had

already been told "no" one year. The next year I was told, "we will look at that next year," and finally I was told, "benchmark and bring whatever you benchmark back next year." I had done so much work coming up to my review, that for me, it was now or never. Speaking to my Council openly, honestly, and frankly was difficult but necessary; I told them that even after I had attained my master's degree, I didn't know what a city secretary was until the third city I worked at, and also how insulting it was for me to report to the governing body just like the city manager, and have numerous staff members reporting to me, yet residents would call me by phone to try and set up a meeting between them and the city manager, just, because my title had the word "secretary" in it. I explained to them how this job was not just for women, and how the word "secretary" was not always inclusive of both men

and women in modern society, and helping to change the title is one way to be more inclusive of both genders.

It was, for me, starting to feel suffocating. Changing my title was not an easy road, I'm not going to act like it was, but I am hopeful it will be an easier road for those of you requesting a title change now. I knew, even before I walked into the room that day, that I was going to receive some massive resistance...and I did. Some of the resistance was discouraging, and some of it was outright disrespectful; however, there were thankfully a few outliers. One of my council members made the case for it not being a big deal because I wasn't asking to get rid of the title city secretary; he said it would perhaps clear up some of the misconceptions of what the CS does. Another councilman said this, while very boisterously slamming his hands down on the table after listening to the others basically be split on the issue. He said, I have two daughters, and I want them be successful.

If one of them called me and said, "Dad, I have two job offers: one is for a city secretary, and one is for a chief governance office/ chief compliance officerwhich should I choose?" I would tell her to choose the CGO/CCO every time, because I think the title city secretary is demeaning, disrespectful, outdated, and does nothing for the future of my daughter." The room was silent. After that, two more of them said okay, I'm fine with it, and it was a 5/4 vote to give me the title.

They let me choose between the two titles that were proposed. How did I come up with those two titles? I give all that credit to my

staff: they came up with them. Then our City Attorney vetted that there was no City Charter conflicts with either title, and based on numerous factors, I elected to go with Chief Compliance Office over Chief Governance Officer.

What would I tell you if you desire to take the route of trying to attain an additional title, a functional title, or replace your existing title? First, I would say be proud of the title CS. My goal was NOT to get rid of it. The title CS is ingrained in all the legal codes that exist (i.e., election code, local govt. code, tax code, etc.). I believe there SHOULD be a CS in the organization, at least or until we, as a body, want to begin the bigger discussion of addressing the legislature on a sweeping change to the title. That said, my advice to conquering the title change is as follows: 1) Do your homework, whatever that homework looks like to you, because only you know your organization best. Is that homework to benchmark other CS duties/responsibilities, or to benchmark titles only, or to benchmark titles and pay? Whatever it is, do it. 2) Anticipate your audience and what will be asked by that audience... what will your CM ask you or your Mayor/ Council? Will they ask you questions based on their own biases...which could be gender, demographics, age, socioeconomic status, etc.?

Be prepared for discomfort from them and for you. Some who have gone through this journey had an easy ride; mine was not one of them. 3) Prepare to answer the most basic of the questions, "Why do you want this change, and how does it benefit the organization and not just you personally?" Elaborate on that response and justify it such that it does benefit not just your organization and you, but TMCA as a whole. All these things are important.

Finally, I realize change comes about in small steps most of the time. For me, this was a change that I was passionate about. I do believe it must be done one-by-one, city-by-city, at the grassroots level first, so that other city councils and other city managers can begin taking notice. A path must be paved, then another, then another in order to build the road Conversely, I believe we as CSs cannot move forward if we are not willing to do it as a group of one in the end—as a whole who can get behind this idea of changing our titles. Grassroots first, then more globally begin moving toward a permanent title change within the legislature.

"What's in a name? That which we call a rose, by any other name would smell as sweet." I don't entirely agree with this. Perhaps names DO make a difference, and perhaps titles DO add to relevance without having to explain and justify what that title is or does. City Secretaries ARE ROSES; maybe we are stuck, and we know it, we feel it, and just don't know what to do about it or don't have the initiative to try and do something about it. All it takes is

one foot in front of the other. Be smart. Be bold. Be brave. Be respectful. If you want a different title or working/functional title, begin asking the question, be told "no" or "come back next year" again and again, but keep asking. That's how we create change, that's how we move forward, that's how we become unstuck, that's when our future begins to evolve and we no longer must explain what our worth is based on a title, that while historical and incredibly worthy, has outlived its historical relevance. Otherwise, a rose is just another flower in the gene pool of flowers, when it should be more significant than the daisy, pansy, or daffodil in its relevance to the huge garden of city government. Be a Rose!

Well, I finally made it—I've completed my TMCCP certification! I started the program in August 2017, and I don't mind telling you that I started to get concerned that I might actually need those 10 years to complete the entire program. When I first started out as a newbie city secretary, I was

the only person in my office, I came to work early, stayed late, AND brought work home. It seemed as if I had no free time to work the program as life and work got in the way. Thankfully, I opted to pre-pay for all of the sessions which allowed me the flexibility to attend seminars as they came available and to study for and to test on the topics that seemed the most pertinent to me at the time. For me, the best way to move forward was to just focus on one item at a time.

The beauty of the way that the program is laid out is that as you are working as a city secretary, you are being exposed to the situations that you are reading about in the study material. You gain insight and knowledge on a variety of situations that you will come across at work. The seminars, study material, and exams build off each other to give you the knowledge you need as you progress through your training and to perform your work. Even if you do not retain all of the specific information, you at least know where to find it!

In addition to the knowledge I gained, one of the added bonuses of the program was how this boosted my confidence level. This has led to me taking on more responsibility and to receive more acknowledgement from my city manager, council, and citizens as well. Becoming involved with my local chapter has also been a positive experience—enriching my professional and personal life. So, let me whole-heartedly encourage you to keep on with the program. Keep pushing forward, one homework session and seminar at a time. Join your local chapter. Get involved. One day you'll realize you only have one more seminar, or one more test to take. The funny thing is, from the beginning we know that this is only

the first step in the journey as recertification is part of the program. So now I stand on the brink of the next phase of the process, thankful for the support I've received so far and looking forward to continuing to learn and to grow and to strengthen the friendships I've made thus far.

Public service codes of ethics are put in place to strengthen values and the intrinsic motivation of public servants. The **Code of Professional Ethics** of the Texas Municipal Clerks Association, Inc., was adopted in the very early days of the Association. The quote above is part of the Code of Professional Ethics that you subscribe to as a member of TMCA. Neutrality and impartiality are essential to our system of government at every level.

The idea of neutrality presupposes a loyalty to our system of government above self or individual. As city clerks your commitment to neutrality demands that you fully support and implement the decisions made in your municipality irrespective of your personal preferences. Additionally, you must provide advice which is objective, independent, nonpartisan, and just. Impartiality involves avoiding conflicts of interest, seeking inclusion, maintaining objectivity, and pursuing the public interest. Moreover, actions and behaviors must be more than impartial—even the appearance of bias is a critical misstep.

As Texas municipal clerks you have every opportunity to influence the public's opinion of local government in a positive way. And you do! As a group and as a profession, municipal clerks are dedicated to the fair and precise implementation of the law and local codes. Our Code of Professional Ethics acts as your guide. Your peers act as your support system. You serve Texas well.



Mrs. Adame informed me that the new assistant city secretary would immediately enroll in the Texas Municipal Clerks Certification Program to become a Texas Registered City Secretary.

In my early years as City Secretary, there was so much to learn such as city policies, agenda procedures, minutes taking, understanding the operation of local government, working with the Mayor, Commissioners, City Manager and the public. I had no idea of the City Secretary's duties. Mrs. Adame was a good mentor, leader, and a great promoter of the TMCA Program. Through her leadership and encouragement, I was able to take on the responsibilities of the Assistant City Secretary and eventually the role as City Secretary for the City of Weslaco in November 6, 1984.

Times were different in the 1980's; we didn't have computers or cell phones. The office had an electric typewriter and everything was manually filed away. The evolution of computers enhanced the functions of the City Secretary in many ways such the storing and processing of data to simplify complicated tasks, the use of floppy disks, and later into the future, agenda and public information softwares, scanning of documents, storing information on the cloud, use of the internet to provide information to the public, computer terminal devices for voting, cell phones, iPads,

and the ability to conduct Zoom meeting, not only with our organization, but through the whole world.

I have worked for almost 46 years in public service, of which 37 years as a City Secretary. I am proud to be a member of the TMCA. I have grown to be a professional, gained a greater sense of confidence and self-esteem.

When I was writing this speech, I found myself stuck on what do I want to say, what do I wanted to communicate. I was stuck in my own head because I was overthinking it. I relaxed, closed my eyes—took a little nap not on purpose by the way—and what came to me was: **BE BOLD**.

Be hold, push yourself, and get comfortable with being uncomfortable. That's not an easy thing to do but we don't do the easy things. We all chose, or in some cases it chose us, a profession that requires us to constantly be the center of a city organization. It is not always in the forefront of everyone's mind but each of us daily are bold.

Be bold do what the ordinary fear—we do that every day. We walk in and tackle the day. We talk to that citizen who is not happy and needs to be heard. Others may fear this but we take that conversation and turn it into a new process or research the answer for them. The only thing we don't do is run from the conversation. The ending may not always be what the citizen wants, but it is what is

available and true, and for that reason we are not fearful.

Being bold is not always being the loudest in the room. You don't have to bust into the room make your announcements and leave. Sometimes being bold in listening to everything, coming up a solution and passing that along, quietly and confidently. Standing firm to your point of view is bold—in the face of what everyone wants, that is in direct contradiction of what can be done, we stand firm. Not ugly or even mad, but firm in our view of what we know to be true. **We are bold.** Our profession is not for the faint of heart. Times require us to step outside our comfort zone, to accomplish what must be accomplished.

lead me to a profession I love. I was fortune enough to have two direct mentors that also happen to be former TMCA presidents. Jean Crawley 1993 and Mary Kayser 2011. My first position with the City of Burleson was working for both in a split position. How fortunate was I? I didn't realize it until later on the opportunity I was given. They that

came into my life and brought their own boldness to show me.

What an exciting year to be the TML Representative for our association. TML worked hard this year to navigating Covid-19 while providing services and information to all its members. They understood the demands of keeping on track while everything was fluid and changing.

The first meeting of the TML Board was held December 4, 2020 (virtual) this meeting was important to set the 2021-2022 Legislative program. It was encouraging to see the statewide representation and how they work together. The main focus really is the health of cities both large and small. The Grassroots and Legislative Services division of TML presented a new revised look for the "Our Home, Our Decision" campaign to be used during the 87th Legislative session. The TML website has resources for all cities to utilize.

Not unlike most cities the financial health of TML was in question because of restrictions and deficits in the economy, however in December the projected deficit was reduced. The projected deficit of \$672,000 turns out to be lower at \$356,000. In October the Audit report was presented to the board with no unfavorable findings or comments.

In March the announcement came that President Karen Hunt (Mayor of Coppell) will no longer be in office and will have to vacate her position. President Elect Martha Castex-Tatum (Vice Mayor pro tem Houston) will fill term until next election. Board voted to move up the elections for President Elect in order to fill the vacancy. Normal elections process begins in June the vote was to move everything up to immediately proceeding the March 5 meeting. In October at the Annual TML Conference Martha Castex-Tatum, City of Houston, Vice Mayor Pro Tem was elected 2022 TML President and David Rutledge, City of Bridge City, Mayor will be President-Elect for 2022.

President Nemer appointed a Legislative Committee to participate in monitoring and testifying if necessary on any bills directly affecting cities. TML staff met weekly with this committee to not only inform us of bills that directly affect our jobs but all bills affecting cities. This support from TML was informative and helpful and we will continue to keep the lines of communication open not only for information received from TML but as a resource for them.

TML staff along with city representatives continue to work on legislative changes and have already began to think about how to provide training resources. The staff worked hard this year and will continue to provide guidance to all its members. TML staff is working on improving their privacy policy to protect their members. The Board approved a draft of a privacy policy to start a framework for how the League will move forward with data collected from the membership. This will be worked on in year 2022 to tighten up the policy and review how

we respond to third party request for membership data and how the league responds to request about our third party vendors.

The TML Conference in Houston was a success with more attendees than the previous conference held in Houston. Thank you from TML for all the cities that attended and for all continued support and participation. Next year's Annual Conference will be held in San Antonio, October 5-7, 2022, and is expected to draw even more attendees than Houston.
